
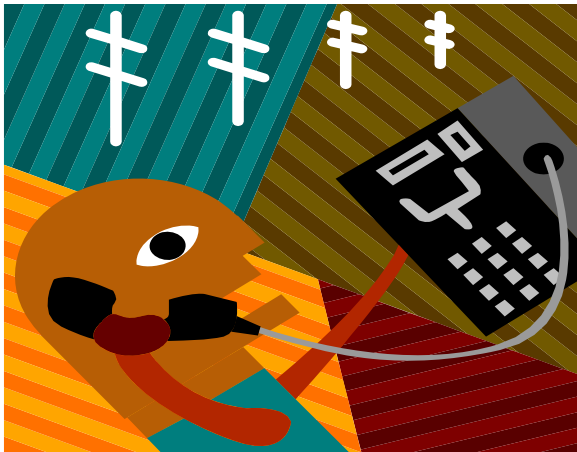

Taking steps now to prepare for disasters and emergencies of all types will go far in ensuring everyone's safety. We have to work together, as a team, to ensure that individuals, families, and communities are prepared for emergencies and disasters. Important steps to take include:</p> <ul style="list-style-type: none"> • Making a family emergency plan. • Getting an emergency supply kit. • Staying informed. • Working as a team to keep everyone safe. <p>September is National Preparedness Month and the perfect time to take action toward making your communities and our nation safer, stronger, and better prepared.</p> <p>Federal Emergency Management Agency's grassroots preparedness initiative, Citizen Corps, supports local opportunities for communities to become engaged in preparedness and resiliency by connecting government and civic leaders, non-governmental organizations, and other community-based programs through participation on their local Citizen Corps Council. Citizen Corps Councils support emergency operations planning, training and exercises, and volunteer opportunities that enhance community safety. Here are a few examples of how you can become more involved in your community:</p> <p>Volunteering for local law enforcement agencies through the Volunteers in Police Service (VIPS) Program or the Douglas County Search and Rescue Team. Volunteers in these programs assist local law enforcement by providing essential support and skills</p> <p>Training to become a member of the Umpqua Valley Community Emergency Response Team (CERT). CERT members</p> <p>support first responders before, during and after a disaster occurs by providing support for preparedness awareness and using their skills to execute response protocols to assist emergency responders</p> <p>Joining a Neighborhood Watch group to assist with crime prevention by working more closely with local law enforcement, and emphasize the importance of emergency preparedness among families and homes in your neighborhood</p> <p>Donating time to a Medical Reserve Corps Unit through volunteering with medical and public health professionals to contribute skills and expertise throughout the year as well as during times of community need</p> <p>Becoming an advocate for fire safety and prevention education in the community and assisting with administrative duties at your local fire station through Fire Corps</p> <p>Getting involved with an American Red Cross Chapter by giving blood to ensure a safe supply, volunteering with your local chapter, getting trained to respond to local disasters like home fires, or making a donation to the Disaster Relief Fund</p> <p>Helping other community members prepare, including those children and adults with disabilities and others with access and functional needs.</p> <p>All over America, communities have organized Citizen Corps Councils to involve local government and non-government in emergency management planning, mitigation, response, and recovery activities. International Phone Scam



Don't respond to emails, phone calls, or web pages which tell you to call an "809," "284," or "876" phone number.

An old long distance phone scam that leads consumers to incur high charges on their phone bills may now affect wireless consumers. In the past, consumers have been fooled into making expensive international calls by scam artists who leave messages on consumers' answering machines or their e-mail accounts. The messages urge consumers to call a number with an "809," "284," "876," or some other area code to collect a prize, find out about a sick relative, employment opportunities, etc.

Wireless consumers are now receiving similar calls from phone numbers with three-digit area codes that appear to be domestic, but are actually associated with international pay-per-call phone numbers. While wireless companies are working to block suspicious numbers on their networks, some consumers may become victims of this scam.

The Scam Works Something Like This:

Your wireless phone rings once or twice and then disconnects the call. When the number appears in your wireless phone log as a missed call, it appears to be a typical domestic telephone number starting with a "649" area code; or you get an e-mail or voicemail (on your residential wired telephone) telling you to call a phone

number with an "809", "284", "876," or some other three-digit international area code.

When you return the call, you assume you are making a domestic long distance call – as "649," "809," "284," "876," and other area codes involved in this scam, appear to be typical three-digit U.S. area codes.

When you dial the three-digit area code plus the number, however, you are connected to a phone number outside the United States, often in Canada or the Caribbean, and are charged expensive international call rates, and may be charged for pay-per-call services as well.

You don't find out about the higher international call rates until you receive your phone bill.

What You Can Do to Minimize the Risk of This Happening to You:

Check any unfamiliar area codes before returning calls.

Be aware that there are many 3-digit area codes (mostly in the Caribbean) that connect callers to international telephone numbers.

If you do not otherwise make international calls, ask your local or wireless phone company to block outgoing international calls on your line.

If you are billed for a call you made as a result of this scam, first try to resolve the matter with your telephone company. If you are unable to resolve it directly, you can file a complaint with the FCC. There is no charge for filing a complaint. You can file your complaint using an FCC on-line complaint form found at esupport.fcc.gov/complaints.htm. You can also file your complaint by calling 1-888-CALL-FCC (1-888-225-5322).

You should also file a complaint with the FTC online at www.ftccomplaintassistant.gov/. You can also submit a complaint by calling the FTC toll-free at 1-877-382-4357.

Amber Alert



Your Douglas County Sheriff's Office encourages you to be the eyes and ears that might save a kidnapped child in our community. Do you own a cell phone that is able to receive text messages? Our hope is that you read the following information and become inspired to become one of the people who may be able to help in locating an abducted child.

AMBER stands for "America's Missing: Broadcast Emergency Response" and was created in 1997 when Dallas-Fort Worth broadcasters teamed with local police to develop an early warning system.

Statistics show the first three hours after a child's abduction are most critical to recovery efforts. Alerts are initiated when the following conditions have been determined:

- There is reasonable belief by law enforcement that an abduction has occurred.
- The abduction is of a child age 17 years or younger.
- The law enforcement agency believes that the child is in imminent danger of serious bodily injury or death.
- There is enough descriptive information about the victim and the abduction for law enforcement to issue an AMBER Alert to assist in the recovery of the child.

- The child's name and other critical data elements, including the Child Abduction flag, have been entered into the National Crime Information Center (NCIC).
- An abducted child, age 17 years or younger, is reported to a local law enforcement agency.
- If the abducted child case meets the recommended criteria, law enforcement issues an AMBER Alert and National Center for Missing & Exploited Children (NCMEC) is notified and provided with the information to include in the alert.
- NCMEC formats the AMBER Alert message and sends it electronically to Syniverse.
- Syniverse sends the AMBER Alert message to wireless carriers participating in the Wireless AMBER Alerts Initiative.

Participating carriers send the AMBER Alert message, in text message format, to their subscribers that have opted in to receive the notices. There is no charge incurred for these text messages. Wireless subscribers, whose wireless devices are capable of receiving text messages, may opt in to receive Wireless AMBER Alerts by registering at www.wirelessamberalerts.org or by visiting their wireless carrier's website.

When they opt in, consumers need to provide their wireless phone numbers, including area code, and designate up to five ZIP codes for which they want to receive Wireless AMBER Alerts. You will only receive alerts for the ZIP codes you registered and you can opt out when you choose.

You can enter your ten-digit wireless phone number on the subscription page to determine if your carrier is participating or you can check the latest listing of participating wireless carriers at <http://www.wirelessfoundation.org/amber/carriers.cfm>
